IT IS HEREBY ORDERED that:

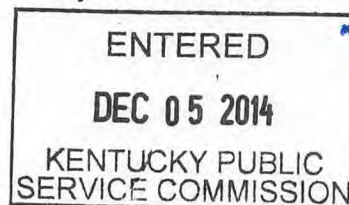
1. The motion of Kroger to intervene is granted.
