

**AMENDED MOTION FOR EXPEDITED REVIEW**

1. **KENERGY CORP.** (“Kenergy”) hereby amends its prior motion to the Kentucky Public Service Commission (“Commission), for expedited review. For its grounds, Kenergy states that subsequent to the filing of the Application in this matter, negotiations with vendors have resulted in Kenergy becoming aware of cost increases associated with delays in vendors performing certain services beyond the project schedule originally envisioned by Kenergy in the initial application. Based on these discussions and the schedule for project milestones, Kenergy requests an order from the Commission by February 24, 2015 to avoid cost increases to the project and the potential need for Kenergy to revise and re-submit a revised application reflecting new project pricing. Therefore, Kenergy requests that the Commission issue an Order as soon as practicable so that the project may stay within the budget proposed in the Application.

WHEREFORE, Kenergy respectfully requests expedited review.
