Our water has been off for two days, February 21 and 22, 2015, and still low water pressure on the present day of February 23, 2015. (Sand Springs Road/ Rt. 1249/Pongo Area)

- A. I would like to know the cause of our water outage, and where the leak was located, and who repaired the water leak?
- B. Also which line was responsible for the water outage, Mt. Vernon or Eastern Rockcastle Water Association, Inc. line?
- C. Why were we completely out of water on Sand Springs Road (Rt. 1249/ Pongo Area) for two days (weekend)? Please describe in detail the cause of this water outage and the cost to repair. (Itemized, please).
- D. 2010 or 2011, Joe Clontz CPA, billed Eastern Rockcastle Water Association, Inc. for assisting the E.R.W.A. with the Internal Revenue Service and obtaining a waiver, I would like a copy of this bill and complete details related to the bill. (Why and for What?) (And the result?) I request the amount the Eastern Rockcastle Association, Inc. was fined by the IRS for failing to file tax exempt forms from 1990 to 2009. Fine was waved by what was the amount?
