

19 Q1. Please state your name and position with the Henderson County Water District.

20 A. Peter Conrad, Superintendent of the Henderson County Water District ("HCWD").

21 Q2. The application requests a certificate of convenience and necessity to install 1,900  
22 radio frequency water meters but the bid solicitation and response was for only  
23 1,800. Please clarify the difference.

24 A. The HCWD intends to install 1,900 new radio frequency water meters if this  
25 application is approved for that amount. The 1,800 bid solicitation was made  
26 because that was the minimum number to be bid to provide the lowest bid price.  
27 The vendor and winning bidder has agreed to provide all 1,900 at the bid price.
