Pursuant to the Commission's February 3, 2015 Order, an Informal Conference ("IC") was held on March 2, 2015. A list of the attendees is attached to this memorandum.

Commission Staff stated that the purpose of the conference was to discuss the show cause proceeding and noted that a summary of the meeting would be prepared after the conclusion of the IC and sent to Jackson Purchase Energy Corporation ("JPEC").

Commission Staff and JPEC discussed the pending show cause action. Commission Staff asked JPEC about its current policies regarding the hiring of independent contractors and its interactions with the individual crews sent by the independent contractors to the job sites. JPEC gave a detailed explanation of its hiring process and its oversight of the crews hired by the independent contractors. JPEC also answered questions from Commission Staff regarding its safety manual, as adopted from the American Public Power Association safety manual, and its review of the safety manuals and safety procedures of its independent contractors. JPEC discussed the contracts its independent contractors sign, specifically the termination clauses within these contracts. Commission Staff and JPEC also discussed the specific incident at issue in this matter.

An agreement in principle was reached between JPEC and Staff to enter into a stipulation of facts and settlement in an effort to resolve all issues in this case. JPEC agreed to pay a monetary penalty in the amount of \$10,000 and, among other things, to thoroughly review the safety manuals of its independent contractors before hiring to ensure that the standards set forth in the independent contractors' safety manuals are at least equal to or exceed the standards set forth in JPEC's own safety manual and to encourage its independent contractors to adopt JPEC's safety manual. JPEC also

agreed to take into consideration the standards set forth in the independent contractors' safety manuals into its hiring criteria. JPEC further agreed to integrate this review into its pre-qualification review of independent contractors during the bidding and hiring process.

Commission Staff asked if there were final comments or questions about the agreed penalties. There being no further discussions, the IC was adjourned.²
