



MOTION TO AMEND PROCEDURAL SCHEDULE OF  
KENTUCKY INDUSTRIAL UTILITY CUSTOMERS, INC.

---

On February 5, 2015, the Kentucky Public Service Commission (“Commission”) issued an Order opening Case No. 2014-00455 to review Big Rivers Electric Corporation’s (“Big Rivers”) fuel adjustment clause for the two-year period from November 1, 2012 through October 31, 2014. The Commission then consolidated Case No. 2014-00230 with Case No. 2014-00455 on February 19, 2015. However, the procedural schedule established by the Commission for the consolidated proceedings did not set forth a deadline for intervenor testimony.

In its February 5, 2015 Order opening Case No. 2014-00455, the Commission states that “[a]ny intervening party that intends to file testimony in this matter shall advise the Commission in writing of its intent to do so and shall, no later than March 23, 2015, move for modification of the procedural schedule, if necessary, to permit the filing of its testimony.”<sup>1</sup> KIUC is an intervening party in this matter and hereby advises the Commission that it intends to file testimony in the above-captioned proceedings.

Accordingly, KIUC respectfully moves that the Commission modify the existing procedural schedule to permit intervenors to file testimony two weeks after the deadline for Big Rivers’ responses to interrogatories and requests for production, which would make the intervenor testimony deadline April 3, 2015. KIUC requests that all other procedural deadlines be shifted an equivalent number of days. By providing intervenors an opportunity



to more fully participate in these proceedings, the Commission will develop a more comprehensive record that may assist the Commission in its decision-making.
