**RE:** Big Rivers Electric Corporation Fuel Adjustment Clause

On March 26, 2015, Commission Staff ("Staff") held a telephonic informal conference ("IC") with Big Rivers Electric Corporation ("Big Rivers") and the Kentucky Industrial Utility Customers, Inc. ("KIUC"). KIUC requested the IC to discuss its motion to compel and to propose a change to the procedural schedule. A list of attendees is attached to this memorandum.

The parties agreed that, outside of the hearing date, each of the remaining steps of the procedural schedule should be moved one week later than currently established. Additionally, Staff indicated that KIUC's motion to compel would be adjudicated as soon as practicable after Big Rivers tenders its response to the motion.
