COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION TO DOUGLAS AND SYLVIA MORRISON

Douglas and Sylvia Morrison ("Mr. and Mrs. Morrison"), pursuant to 807 KAR 5:001, are to file with the Commission the original and five copies of the following information, with a copy to all parties of record. The information requested herein is due on or before September 1, 2015. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry. Mr. and Mrs. Morrison shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Mr. and Mrs. Morrison fail or refuse to furnish all or part of the requested information, Mr. and Mrs. Morrison shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a document containing personal information, Mr. and Mrs. Morrison shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the document so that personal information, including but not limited to, customer account numbers, cannot be read.

1. Refer to your response to Staff's First Request for Information, Item 4, in which you describe your neighbors' complaints regarding the outdoor light attached to Kentucky Power Company ("Kentucky Power") Pole No. 2184. In your Complaint, you indicated that you had filed complaints with Kentucky Power regarding that outdoor light.

a. Confirm that you made a complaint to Kentucky Power regarding the outdoor light attached to Kentucky Power Pole No. 2184.

b. State the date or dates that you, and not your neighbors, made a complaint to Kentucky Power regarding this outdoor light.

c. State whether you made the complaint in person, in writing, or by telephone.

d. Identify to whom at Kentucky Power you made the complaint. For example, state whether you called or wrote the Customer Operations Center, or whether you spoke with a repair technician.

2. Refer to page 3 of your Complaint, where you state that AEP told you that it couldn't move the outdoor light attached to Kentucky Power Pole No. 2184. State who at Kentucky Power made that statement and when that statement was made.

3. Refer to pages 17-19 of your response to Staff's First Request for Information, where you provided pictures of the outdoor light attached to your shed.

a. State whether the light attached to the shed can be manually controlled by a switch.

b. State whether the light can be operated in the daytime.
