<u>ORDER</u>

On May 20, 2015, Garrard County Water Association, Inc. ("Garrard County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹ The initial filing was found to be deficient. On May 29, 2015, Garrard County filed information that cured the deficiencies, and the application was accepted as filed as of that date.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Garrard County purchases water from the city of Lancaster ("Lancaster"), the city of Danville ("Danville"), and the city of Berea ("Berea").

2. Lancaster notified Garrard County that effective June 3, 2015, Lancaster would increase its wholesale water rate to Garrard County from \$2.12 per 1,000 gallons to \$2.15 per 1,000 gallons.² Garrard County proposed to increase the water rates to its

customers, effective June 3, 2015, as requested by letter received on May 29, 2015,³ to reflect the increased cost of purchased water.

3. Garrard County proposed a purchased water adjustment factor of \$0.03 per 1,000 gallons.

4. During the 12 months ended April 30, 2015, Garrard County purchased 277,494,304 gallons of water from Lancaster, 82,738,226 gallons of water from Danville, and 24,850,356 gallons of water from Berea and sold 305,236,200 gallons. The increase in the cost of purchased water is \$8,324.83, resulting in a purchased water adjustment of \$0.03 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.03 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. The rates proposed by Garrard County, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered on and after June 3, 2015.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.03 per 1,000 gallons is approved.

2. Garrard County's proposed rates are approved for water service rendered on and after June 3, 2015.

3. Within 20 days of the date of this Order, Garrard County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
