ORDER

On March 27, 2015, the Commission opened Case No. 2015-00117¹ after receiving a letter from Angela Lemke, Owner and President of PhoneAid Communications Corp. ("PhoneAid"), requesting that the Commission revoke PhoneAid's status as an eligible telecommunications carrier ("ETC"). Pursuant to 807 KAR 5:001, Section 4(4), a person cannot file with the Commission a paper on behalf of another person unless the person is an attorney licensed to practice law in Kentucky. Based upon information and the belief that Ms. Lemke is not an attorney licensed to practice law in Kentucky, the Commission issued an Order on May 5, 2015, directing PhoneAid to have an attorney file an entry of appearance or the case would be dismissed. PhoneAid did not comply with the Order and Case No. 2015-00117 was closed without revoking PhoneAid's ETC status.

Being otherwise sufficiently advised, the Commission, on its own motion, opens this case to revoke PhoneAid's ETC status.

On November 24, 2009, the Commission granted the request of PhoneAid for designation as an ETC.² PhoneAid was authorized to receive low-income support for the purpose of providing Lifeline and Link-Up service.

In its March 27, 2015 letter in Case No. 2015-00117, PhoneAid requests that its ETC designation be relinquished immediately. PhoneAid states that it has ceased operations. PhoneAid further states that it filed a corporate dissolution with the state of Florida, where it was incorporated, and filed a certificate of withdrawal of its authority to transact business in Kentucky with the Kentucky Secretary of State. A copy of the certificate of withdrawal filed with the Kentucky Secretary of State is attached as an appendix to the Order. PhoneAid states that it has no customers.³

Under 47 U.S.C. § 214(e)(4), a State commission shall permit a carrier to relinquish its ETC designation in any area served by more than one ETC. The incumbent Local Exchange carrier, AT&T Kentucky, is designated as ETC, and the Commission is aware that other utilities are designated as ETCs in the area. Because other ETCs currently serve the entire area in which PhoneAid is designated as an ETC in Kentucky, it is unnecessary to provide notice to those carriers to permit them to purchase or construct facilities to ensure that customers will continue to receive service.

47 U.S.C. § 214 (e)(4) states in part:

A state commission . . . shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunications carrier designation for an area served

by more than one eligible telecommunications carrier shall give advance notice to the State commission . . . of such relinguishment. Prior to permitting a telecommunications carrier designated as an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State commission . . . shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The State commission . . . shall establish a time, not to exceed one year after the State commission . . . approves such relinguishment under this paragraph, within which such purchase or construction shall be completed.

Based on the evidence and having been sufficiently advised, the Commission

finds that, pursuant to 47 U.S.C. § 214(e)(4), there is more than one ETC in the area of

relinquishment, and those carriers have sufficient facilities for the provision of service.

IT IS THEREFORE ORDERED that:

- 1. This proceeding is opened to revoke PhoneAid's status as an ETC.
- 2. PhoneAid's status as an ETC is revoked effective as of the date of this


Order.

3. PhoneAid shall not provide telecommunication service in Kentucky without

first requesting and receiving Commission approval to do so.

4. This case is now closed and removed from the Commission's docket.
