COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO GOGO, LLC

GoGo, LLC, pursuant to 807 KAR 5:001, is to file with the Commission the original and five copies of the following information, with a copy to all parties of record. The information requested herein is due on or before January 8, 2016. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

GoGo, LLC shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which GoGo, LLC fails or refuses to furnish all or part of the requested information, GoGo, LLC shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, GoGo, LLC shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

- Refer to GoGo, LLC's Application, numbered paragraph 1, which states
 that GoGo, LLC "is authorized to transact business in the Commonwealth of Kentucky."

 Provide a copy of the certificate of authority to transact business in the Commonwealth
 of Kentucky filed with the Kentucky Secretary of State.
- GoGo, LLC is not registered with the Commission as a utility. Explain GoGo, LLC's failure to register with the Commission. State whether GoGo, LLC plans to register with the Commission.
- 3. Refer to KRS 278.650. Does GoGo, LLC propose to construct an antenna tower for either cellular telecommunications services or personal communications services? If so, explain how the services GoGo, LLC plans to offer meet the definitions of cellular telecommunications services or personal communications services. If not,

explain the types of services that GoGo, LLC will provide for which the proposed tower will be built, and how those services do not meet the definition of cellular telecommunications services or personal communications services.
