<u>ORDER</u>

On December 2, 1999, in Case No. 1999-00312, the Commission approved rates for Millennium Energy, Inc. ("Millennium") and provided for their further adjustment in accordance with Millennium's Gas Cost Adjustment clause.¹

On November 30, 2015, Millennium filed its proposed Gas Cost Recovery ("GCR") rate application to be effective January 1, 2016.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's notice includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Millennium's notice sets out an Expected Gas Cost ("EGC") of \$3.1676 per Mcf, which is a decrease of \$.5318 per Mcf from its previous EGC of \$3.6994 per Mcf.

3. Millennium's notice sets out no Refund Adjustment.

4. Millennium's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0876) per Mcf. Millennium's total AA is (\$.1274) per Mcf, which is a decrease of \$.0403 per Mcf from the previous total AA of (\$.0871) per Mcf.

5. Millennium's notice sets out a current quarter Balance Adjustment ("BA") of (\$.001230) per Mcf. Millennium's total BA is (\$.0952) per Mcf, which is a decrease of \$.0008 per Mcf from the previous total BA of (\$.0944) per Mcf.

6. Millennium's notice sets out a GCR rate of \$2.9450 per Mcf, which is a decrease of \$.5729 per Mcf from the previous GCR rate of \$3.5179 per Mcf.

7. The rates as proposed by Millennium and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after January 1, 2016.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Millennium and set forth in the Appendix to this Order are approved for service rendered on and after January 1, 2016.

2. Within 20 days of the date of this Order, Millennium shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
