COMMISSION STAFF'S THIRD REQUEST FOR INFORMATION  
TO THE CITY OF AUGUSTA, KENTUCKY

The city of Augusta ("Augusta"), pursuant to 807 KAR 5:001, is to file with the Commission the original in paper medium and an electronic copy of the following information. The information requested herein is due no later than May 26, 2015. Responses to requests for information in paper medium shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Augusta shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which

Augusta fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, August shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Augusta's response to Commission Staff's First Request for Information, Item 26.

a. Provide the total rate case expense, to date, incurred by the city of Augusta for this proceeding. Provide all supporting documentation.

b. State whether Augusta will seek recovery of its rate case expense through the assessment of a monthly surcharge to the Bracken County Water District ("Bracken County"), and if so, provide the projected amount of the surcharge and the number of months that the surcharge will be in effect.

c. If Augusta plans to seek recovery of its rate case expense through a method other than a monthly surcharge, provide a detailed description of the method of recovery.

2. Refer to Augusta's response to Bracken County's First Request for Information, Items 25 and 26.

a. Provide any additional expenses that have been identified that were allocated to the Water Treatment Plant that should have been allocated to another department of Augusta.

b. Provide any additional expenses that were allocated to another department of Augusta that should have been allocated to the Water Treatment Plant.
