
**STATEMENT OF
COLUMBIA GAS OF KENTUCKY, INC.**

On March 12, 2015, pursuant to 807 KAR 5:022, Section 18, Columbia Gas of Kentucky, Inc. ("Columbia") applied for a limited deviation from 807 KAR 5:022, Section 14(22)(a), the Commission's regulation regarding pressure limiting and regulating stations: telemetering or recording gauges. Columbia has responded to three rounds of information requests issued by Commission Staff ("Staff"). On March 17, 2016, Columbia participated in an informal conference with Staff and on May 6, 2016, filed a response to the IC Memorandum. By Order dated July 21, 2016, the Commission directed Columbia to file a statement as to whether there are any material issues of fact that warrant a hearing, or whether this case may be submitted for adjudication based on the existing record without a hearing.

Columbia hereby notifies the Commission that in light of the record already developed in this case Columbia recommends that this case be submitted for adjudication based on the existing record without a hearing.
