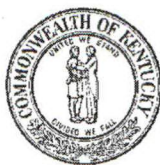

INTRA-AGENCY MEMORANDUM

KENTUCKY PUBLIC SERVICE COMMISSION

RE: Informal Conference of June 5, 2015

Pursuant to a June 6, 2015 Commission Staff Notice, an informal conference was held in this matter on June 5, 2015. A list of attendees is attached.

Beginning the conference, the parties discussed the need for Friendly Park Development, Inc. (“Friendly Park”) to apply for a new discharge permit as well as the necessity of Cedar Hills Disposal Sanitation Corporation (“Cedar Hills”) maintaining its current permit. Division of Water (“DOW”) representatives stated that after a permit expires an entirely new permit must be applied for and obtained by the utility to avoid discharge violations.

The parties next discussed funding issues. Representatives from the Regional Water Resource Agency (“RWRA”) stated that to replace both systems would cost in the range of \$600,000-\$1,200,000 for Cedar Hills and \$300,000-\$700,000 for Friendly Park. To instead connect on to the existing RWRA system, which is the preferable option, would cost approximately \$3,500,000. Daviess County officials stated that prior to proceeding with any potential takeover of the systems additional investigation is required into the utilities’ conditions and that the necessary work will require approximately \$20,000-\$25,000. The parties discussed whether any entity may have funding available. The Kentucky Infrastructure Authority’s ability to provide emergency funding was specifically discussed.

Finally, counsel for all parties agreed that to provide for an opportunity to bring both utilities’ discharge permits into good standing and to review the utilities’ conditions, the cases should be held in abeyance until October 1, 2015, however counsel for the utilities indicated that the proposals would first need to be discussed with his client and that he would report back to the parties during the week of June 8, 2015. Commission Staff closed in stating that a motion from one or both of the parties will be required to modify the existing procedural schedule and hold the case in abeyance.

Finding that no party had any further questions, the conference was adjourned.
