RE: Informal Conference of February 18, 2016

Pursuant to Commission Staff's February 18, 2016 notice, an informal conference was held in this matter on February 18, 2016. A list of attendees is attached.

Beginning the conference, counsel for Daviess County Fiscal Court ("Daviess County") Claud Porter noted that issues related to the Regional Water Resource Agency's ("RWRA") EPA consent decree remain a concern for RWRA in the event it takes over responsibility for the Cedar Hills Disposal Sanitation Corporation's ("Cedar Hills") and Friendly Park Development, Inc.'s ("Friendly Park") treatment plants.

Mr. Porter proposed entering into an agreed order with the utilities for the purpose of recommending findings to the Commission. Mr. Beyer for Commission Staff stated that the parties are welcome to enter agreed or recommended findings, and that any such agreement would likely be discussed at the February 23, 2016 hearing and therefore recommended having a witness available to discuss the contents and rationale of the proposed filing. Mr. Beyer further stated that the Commission's final order in this matter would more directly relate to whether the utilities have met the statutory criteria for abandonment, and the proposed findings may be of more benefit to include in an agreed Franklin Circuit Court order appointing RWRA as receiver.

Finding that no party had any further questions the conference was adjourned.
