Motion For Leave To File An Amended Answer

Kentucky Power Company moves the Public Service Commission of Kentucky for an Order granting it leave to file the tendered amended answer to the complaint herein. In support thereof Kentucky Power states:

1. Subsequent to filing its answer, and in connection with its further investigation to provide answers to Staff's August 12, 2015 data requests, the Company determined that paragraph 5 of its answer was incomplete. Accordingly, the Company respectfully requests leave to file its amended answer supplementing paragraph 5 of its May 15, 2015 answer by adding subparagraph 5(p):

(p) When the Company's service technician, Kevin Brown, viewed the lamp affixed to the Complainants' outbuilding on March 26, 2015 he noted a blue-colored extension cord running from the Complainants' residence to the lamp affixed to the outbuilding. The cord exited the residence and was affixed to the back of the Complainants' residence. The cord spanned the distance between the residence and outbuilding at a height of approximately eight feet. As viewed by Mr. Brown, the cord entered the outbuilding and then exited the outbuilding

and ran up the arm of the lamp affixed to the outbuilding. Such an installation is not provided by the Company.

2. For clarity, the amended answer also changes the internal references in the amended answer from "answer" to "amended answer."

3. Granting leave to file the tendered amended answer will provide the Commission with a more complete understanding of the facts underlying the Complaint and will not prejudice the Complainants. No hearing date has been established in this matter.

WHEREFORE, Kentucky Power Company respectfully requests the Commission

to enter an Order:

- 1. Granting Kentucky Power leave to file the tendered Amended Answer; and
- 2. Granting Kentucky Power all further relief to which it may be entitled.
