The North Shelby Water Company respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The Company was recently notified by its supplier, Louisville Water Company, that it will increase meter service charges by \$73.14 per month and wholesale rates by \$0.05 per 1000 gallons. These increases will take effect July 1, 2015. The result of these increases is \$13,338.73 in additional yearly supply cost for the Company. This translates into \$0.04 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.

Louisville Water Company currently charges North Shelby Water Company a \$161.88 monthly meter fee, \$1.80 per thousand gallons, and \$0.30 elevated service area surcharge per thousand gallons, for a total rate of \$2.10 per thousand gallons.

Louisville Water Company proposes to charge North Shelby Water Company a \$175.35 monthly meter fee, and \$1.80 per thousand gallons, and \$0.35 elevated service area surcharge per thousand gallons, for a total rate of \$2.15 per thousand gallons, effective July 1, 2015.

6.02.03 ELEVATED SERVICE AREA SURCHARGE

All customers shall pay a surcharge of \$0.35 per thousand gallons if water must be delivered at a higher elevation than the general pressure plane served by the Crescent Hill/Cardinal Hill System, excluding customers in the Kentucky Turnpike #2.

6.03 WHOLESALE CUSTOMERS (Effective July 1, 2015)

Wholesale customers which purchase water for resale wherever situated shall be charged: \$1.80 per thousand gallons for all water purchased, the elevated service area surcharge of \$0.35 per thousand gallons, if applicable, and the service charge shall be charged in accordance with 6.02.01.

MINIMUM CHARGE N/A

DELAY CHARGE

In the event that payment for any charge is not made within twenty (20) days from the billing date, the net amount of the bill shall be increased by 5% and the gross amount thus determined must be paid.
