ADDENDUM NO. 1

North Marshall Waterline Upgrades - A.I. #2955

To All Bidders:

The following changes, additions, and/or deletions are hereby made a part of the Contract Documents for the **NORTH MARSHALL WATERLINE UPGRADES - AI #2955**, as fully and completely as if the same were fully set forth therein. Receipt of this Addendum <u>must</u> be acknowledged on the Bid Form for the bid to be considered complete.

- **1. General:** CLARIFICATIONS.
 - **A.** All existing water meters must be reconnected to the new mains. It is the Contractors' responsibility to connect all existing meters to the new mains. The existing mains' locations are not known exactly in many locations.
 - **B.** Information on the Legends are for informational purposes only and must be verified by the Bidder. The number of fire hydrants indicate the number that have to be connected to the new main most are new but some are relocated as noted on the drawings. Lengths of casings, etc., are graphically shown but the lengths are to be determined in the field to insure the proper length is installed. Casings typically extend five feet past the ditch lines on each side of a roadway.
 - **C.** Details are not shown for each connection. Details are for clarification of the work to be required.
 - D. Unless specifically noted on the drawings, fire hydrants (not flush hydrants) will be used at all locations. These will be designated for flushing use only per State guidelines. See Technical Specification W-2, Paragraph 2.04 and 2.05 (Page 3) and Attachment "B" (Page 13) indicates the approximate number of fire hydrants to be used.
 - E. Generally all supply water lines in the Moor's Camp Resort complex will be replaced with 6" PVC lines.
- 2. Sheet W-1: Revision No. 1 of Sheet W-1 has been reissued.
- 3. Sheet W-2: Clarification The new line starts at the existing valve shown at the intersection of Impala Drive and Ridge Road. Detail "B" is not located in the street.

- **4. Sheet W-3:** Clarification New lines shall be tapped to the existing supply main at two locations. Other connections may be turned off for short periods of time to make the other connections.
- Sheet W-4: Clarification Connect new main to the existing main using an existing gate valve. The casings may be reused if found in acceptable condition. See Detail "A".
- 6. Sheet W-6: Clarification The new fire hydrant is near an existing power pole.
- **7. Sheet W-7:** Clarification The new waterline will be above the existing gas transmission lines.
- 8. Sheet W-9: Clarification There are two new fire hydrants. One existing fire hydrant to be removed from service as noted.
- 9. Sheet W-11: Location of exiting main is unknown.
- 10. Sheet W-12: Clarification Connection of new main is to an existing gate valve at Buffalo Road. HDPE pipe runs from the gate valve at the fire hydrant shown at the Ladonna Knoth property to the gate valve on Sheet W-13 at the intersection of Clinton Road. We will allow this length of HDPE pipe to be installed with Certa-Lok Yelomine. There should be 4 fire hydrants listed in the Legend instead of 3 each.
- 11. Sheet W-15: Revision No. 1 of Sheet W-15 has been reissued. The Waterline Contractor is responsible for installing the 10" PVC Main up to and including the gate valve nearest the new tank. This includes the fire hydrant, all gate valves and thrust blocks. The water tank Contractor is responsible for the installation of the 10" PVC from the gate valve to the tank. The water tank Contractor is also responsible for the 8" overflow line and headwall; all site work; installation of the driveway; and construction of the chain link fence and sliding gate.
- **12. Sheet W-16:** Revision No. 1 of Sheet W-16 has been reissued to more clearly show the location of the new 8" main.
- **13. Bid Form:** Complete "Attachment A" to provide unit pricing for service main addition by foot.

All other requirements remain as stated. The Bid date and time remains at 11:30 AM on February 13, 2015, at the North Marshall Water District Office.
