Irvine Municipal Utilities will file a proposed rate schedule which will increase, by 1.5 percent, the rate(s) which it currently charges to Estill County Water and Sewer District for water service. Irvine Municipal Utilities currently charges Estill County Water and Sewer District \$2.327 per 1,000 gallons of water service. It proposes to charge Estill County Water and Sewer District \$2.362 per 1,000 gallons for water service effective July 19, 2014. (The bill reflecting the increase will be due on September 1st 2014 for usage between July 19^h and August 19th 2014). The rates listed exclude the \$0.19 Kentucky River Authority Assessment per 1,000 gallons sold, which was increased \$0.07 cents April 16th, 2013.

The rates contained in this notice are the rates proposed by Irvine Municipal Utilities. The Public Service Commission, however, may order rates to be charged that differ from the proposed rates contained in this notice.

Any corporation, association, or person with a substantial interest in the matter may by written request, within thirty (30) days after publication or mailing of this notice of the proposed rate changes to intervene. Intervention may be granted beyond the thirty (30) day period for good cause shown.
