Section 1(1). "Application" means:

- X A completed Purchased Water Adjustment Form 1
- X A schedule listing current and proposed rates
- X A copy of the supplier's notice showing a change in the supplier's base rate
- X The calculation and all supporting documents used to determine the change in purchased water costs sufficient to determine the accuracy of the calculation
- X A copy of the resolution or other document of the utility's governing body authorizing the proposed rates

If the applicant is a water district and proposes to increase any of its rates for service, a statement from an authorized official of the district indicating the date its proposed rate adjustment was reported to the governing body of the county in which the largest number of its customers reside and the date it presented testimony, or is scheduled to present testimony
