

The letter included was sent to the County Judge also includes the Sedalia Board members resignation. I know there is a merger process but in this instance there is no one to merge with, just acquisition. We are currently operating the system and Graves County has agreed to take in the Sedalia System. This would be the 7<sup>th</sup> system in the Graves County Water consolidation and we are currently operating them under Sedalia's existing tariff. 
