Pursuant to the Commission Staff's January 8, 2016 notice, a telephonic informal conference was held in this matter on January 12, 2016, to discuss the status of and issues in this case. A sign-in sheet containing the names of the attendees is attached.

At the start of the conference, Mr. Spenard stated that Commission Staff would prepare minutes of the conference for the case record, that a copy of the minutes would be provided to all parties, and that all parties would be given an opportunity to submit written comments upon those minutes. Mr. Spenard stated that the views of Staff were not binding on the Commissioners.

Staff and the representatives of Graves County Water District ("Graves District") discussed tariff issues relating to the proposed merger of Graves District with Sedalia Water District ("Sedalia District"). Staff and the representative of Graves District also discussed issues relating to KRS 74.363(4) and post-merger retirement of debt.
