At the start of the conference, Mr. Spenard stated that Commission Staff ("Staff") would prepare minutes of the conference for the case record, that a copy of the minutes would be provided to all parties, and that all parties would be given an opportunity to submit written comments upon those minutes. Mr. Spenard stated that the views of Staff were not binding on the Commissioners.

Staff provided a summary of the procedural history of the case. Knott County Water and Sewer, Inc., d/b/a Knott County Water and Sewer District and Troublesome Creek Environmental Authority, Inc. (individually "Knott District" and "TEA"; collectively the "Joint Applicants") have filed for Commission approval of the transfer of the ownership and control of a jurisdictional asset from TEA to Knott District. Staff stated

that the Commission must render a decision in this matter on or before December 30, 2015, the date of the statutory deadline for a decision.

Staff and the Joint Applicants discussed: The Joint Applicants' response to the Commission's Initial Request for Information, Item 4(a), concerning a Kentucky Infrastructure Authority Ioan; a stipend that Knott County Water and Sewer, Inc. proposes to pay to Troublesome Creek Environmental Authority, Inc.; and a project known as the "HWY 80 project."

During the discussions, Staff expressed a concern that Knott District's current revenues from its sewer operations may not be sufficient to cover Knott District' cost of sewer operations. Staff also expressed concerns regarding the stipend payment and stated that the stipend could be construed as a contribution or donation unrelated to the provision of utility service. Staff also indicated the need for information concerning the HWY 80 project and addressed TEA's accounting treatment for the project. Staff also discussed issues concerning TEA's customer count.

The Joint Applicants stated that TEA's ability to move forward on the HYW 80 project is contingent upon the transfer of the jurisdictional asset that is the subject of this application. The HWY 80 project is scheduled to add approximately 120 to 150 homes, and TEA will eventually transfer the HWY 80 project to Knott District. The Joint Applicants indicated that TEA is functioning as an administrator for the HWY 80 project, and the stipend payments are associated with allowing TEA to continue to exist. The Joint Applicants stated that payment of the stipend would cease upon approval of funding for the HWY 80 project.

The Joint Applicants stated that they would file additional information into the record including, the current certification for Knott District's licensed wastewater treatment plant operator, pro forma information for the HWY 80 project and a list of TEA expenses for the next two years. The Joint Applicants stated that they would consider the concerns expressed by Staff regarding the stipend and might amend the agreement in order to address those concerns. The Joint Applicants indicated that they would file the information as quickly as possible and anticipated that two weeks was a reasonable amount of time. The Joint Applicants stated they had no interest in a formal hearing on their application.

There being no further business, the informal conference adjourned.
