Responses to Filing Deficiencies

- (1) 807 KAR 5:001, Section 14(3) - If applicant is a limited liability corporation, the applicant shall identify in the application the state in which it is organized and the date on which it was organized, attest that it is in good standing in the state in which it is organized, and, if it is not a Kentucky limited liability company, state whether it is authorized to transact business in Kentucky.
 - **Answer to (1):** Bush Gardens Enterprises, LLC is a limited liability company organized in the state of Kentucky on June 22, 2015. Bush Gardens Enterprises is currently in good standing in the state of Kentucky.

- (2) 807 KAR 5:076, Section 4(1)(e)- Most recent state and federal tax returns.
 - **Answer to (2):** This information does not exist for Bush Gardens Enterprises, LLC. Bush Gardens Enterprises, LLC has never filed state or federal tax returns.
