

This is to inform you that the Kentucky Public Service Commission has scheduled a Formal Hearing in Case 2015-0306, "Adjustment in Rates Pursuant to the Alternative Rate Filing Procedure for Small Utilities and Tariff," requested by Bush Gardens Enterprises, LLC's ("BGE").

The details concerning this Formal Hearing are as follows:

- Purpose: For the Public Service Commission to hear evidence to assist in setting a sewer rate for BGE customers.
- BGE has proposed a monthly service rate of \$194.61 per month. Upon review, Public Service Commission Staff has recommended a monthly service rate of \$127.33.
