Comes now Bush Gardens Enterprises, LLC ("Bush Gardens"), by counsel, hereby provides supplemental information for its previous Answers to the Commission's Staff's Initial Requests for Information:

QUESTION 9a:

Refer to the Application, page 13 of 27, Item d.-Insurance.

a. Provide a copy of the general liability policy that was purchased by Bush Gardens for the amount of \$2,882.

ORIGINAL ANSWER TO NO. 9(A): Please see general liability policy attached as Exhibit 11. Notice that the premium is actually \$2,724.80. This is cheaper than the value on the application. The reasoning for the variance from the application is that the original

quote from the same company was \$2,882. Only a partial payment was made for the insurance and we accidently used the original quote to determine the total policy price.
