RESPONSE TO REQUEST BY COMMISSION FOR INFORMATION TO GOGO, LLC

GoGo, LLC, ("GoGo") by counsel, does hereby submit the following information in response to the Commission's request in regards to the above Application. The information found in this document on behalf of the Applicant is true and accurate to the best of my knowledge, information, and belief formed after a reasonable inquiry.

GoGo is a leading global aero-communications service provider that offers in-flight internet, entertainment, text messaging, voice, connected aircraft services and a host of other communications related services to the commercial and business aviation markets. GoGo operates a commercial mobile radio service and is governed under the Code of Federal Regulations as an Air-Ground Radiotelephone Service provider.¹ The Federal Communications Commission Wireless Telecommunications Bureau issued GoGo a Commercial Aviation Air-Ground Radiotelephone license covering the U.S. and Possessions. A copy of

said license was provided in Exhibit H of the Application. GoGo operates their equipment within the 800 mHz cellular band. GoGo's land based locations are designed by in-house radio frequency engineers in order to maximize the coverage objective.

Each numbered section below corresponds to the numbered paragraph found on Commission's request.

- Line 8, Paragraph 1 of the Application is hereby replaced with the following: "GoGo is in good standing with the State of Delaware and has submitted a certificate of authority to transact business in the Commonwealth of Kentucky to the Kentucky Secretary of State." A copy of the certificate of authority to transact business in the Commonwealth of Kentucky submitted to the Kentucky Secretary of State is attached as Exhibit 1.
- 2. GoGo's failure to register with the Commission as a utility was an administrative oversight. GoGo is currently in the process of completing the necessary form(s) and will register with the Commission as expeditiously as possible. GoGo further confirms their status as a commercial mobile radio service subject to limited regulation by the Commission.²
- GoGo proposes to construct an antenna tower for cellular telecommunication services. GoGo operates an Air-Ground Radiotelephone service that allows GoGo, as licensee holder, to provide two-way voice, fax and data services for hire to subscribers in

aircraft, in-flight or on the ground. GoGo operates on a cellular network utilizing the 800 mHz spectrum and CDMA EV-DO technology. The same technology used by wireless carriers Sprint and Verizon Wireless.

GoGo submits the above information without prejudice and respectfully defers to the Commission's decision regarding the proper jurisdiction to render approval for GoGo's proposed wireless communications facility in Rockcastle County.
