ORDER

On September 21, 2015, Inter-County Energy Cooperative Corporation, Inc. ("Inter-County") tendered its application ("Application") to implement a Prepay Service Tariff ("Prepay Tariff"), with a proposed effective date of October 22, 2015. On September 24, 2015, the Commission issued an Order rejecting the Application for filing due to Inter-County's failure to have the Application signed by a Kentucky-licensed attorney as required by the Commission's regulations, and directing Inter-County to have an attorney licensed to practice law in Kentucky file an entry of appearance on behalf of Inter-County in this matter. On September 25, 2015, the Hon. J. Hadden Dean, an attorney licensed in Kentucky, filed an entry of appearance as counsel for Inter-County and Inter-County re-submitted its Application under the signature of its counsel. The Prepay Tariff submitted with the September 25, 2015 Application proposed an effective date of October 26, 2015.

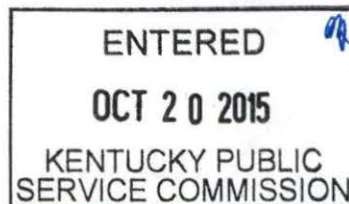
Based on a review of the Application as submitted on September 25, 2015, the Commission finds that Inter-County has fully complied with the requirements of the September 24, 2015 Order and Inter-County's Application is deemed filed as of September 25, 2015. The Commission further finds that an investigation will be

necessary to determine the reasonableness of the proposed Prepay Tariff and that the investigation cannot be completed by October 26, 2015. Therefore, pursuant to KRS 278.190(2), the Commission will suspend the effective date of the proposed Prepay Tariff for five months.

IT IS THEREFORE ORDERED that:

1. Inter-County's proposed Prepay Tariff is hereby suspended for five months from October 26, 2015, up to and including March 25, 2016.
2. Nothing shall prevent the Commission from issuing an Order prior to the end of the suspension period.
