To that end, we require the minutes of the Jessamine County Fiscal Court in which the Fiscal Court approved Claude Lawson to be a Commissioner on the Jessamine County Water District No. 1 Board. We believe that the approval may have occurred in February or March 2011.

We respectfully request that within 10 days of the date of this letter you mail to the Commission a copy of the Jessamine County Fiscal Court minutes in which Claude Lawson was approved as a Commissioner for his term expiring in March 2015.
