RE: Mountain Water District; Rhonda James, Commissioner and Chairperson; Lester "John" Collins, Commissioner; Toni Akers, Former Commissioner; and Mike Litafik, Former Commissioner Alleged Failure to Comply with KRS 278.300(1).

Pursuant to the Commission's December 7, 2015 Order, an informal conference was held on January 5, 2016, at the Commission's offices in Frankfort, Kentucky. The purpose of the informal conference was to discuss any issues relating to the case. A list of the attendees is attached hereto.

Commission Staff stated that it had reviewed Respondents' responses to the Commission's November 2, 2015 Order opening this case and noted the case was scheduled for a hearing before the Commission on February 2, 2016. Counsel for Respondents summarized their position and discussed the procedural posture of the case, including pending issues of law that remain unresolved. Commission Staff and Respondents then discussed the possibility of reaching a stipulation agreement in settlement of this case. The next course of action is for Commission Staff to transmit to Respondents' counsel proposed stipulation terms for review.

There being no further discussion, the informal conference was adjourned.
