<u>ORDER</u>

On November 13, 2015, Louisville Gas and Electric Company and Kentucky Utilities Company (collectively "LG&E/KU") filed with the Commission an application for authorization to install and operate electric vehicle charging stations, approval of certain tariffs and a depreciation rate related to the charging stations, and a deviation from the requirements of certain Commission regulations. The application proposes that the tariffs become effective on December 13, 2015. Based upon our initial review of LG&E/KU's proposed tariffs, the Commission finds that an investigation will be necessary to determine the reasonableness of the proposed tariffs, and that the investigation cannot be completed by December 13, 2015. Therefore, pursuant to KRS 278.190(2), the Commission will suspend the effective date of the proposed tariffs for five months.

IT IS THEREFORE ORDERED that:

1. LG&E/KU's proposed tariffs are suspended for five months from December 13, 2015, up to and including May 12, 2016.

2. Nothing shall prevent the Commission from issuing further Orders in this matter prior to the end of the suspension period.
