ORDER

The matter is before the Commission upon a motion filed by East Kentucky Power Cooperative, Inc. ("EKPC") requesting an extension of time to comply with ordering paragraph 5 of the Commission's December 1, 2015 Order in Case No. 2015-00267,<sup>1</sup> which required EKPC to file, within 30 days of the closing of the Bluegrass Generation Station ("Bluegrass Station") transaction, the journal entries it made to record the transaction. In support of its motion, EKPC stated that the Bluegrass Station acquisition was consummated on December 29, 2015, and that EKPC has been working diligently to finalize its financial records for the 2015 fiscal year, which would include the journal entries related to the Bluegrass Station transaction. Noting that it has yet to close its books for the 2015 fiscal year, EKPC requests an extension of 15 days to submit the journal entries to provide the Commission with accurate and appropriate information related to the acquisition's accounting.

Having reviewed EKPC's motion and being otherwise sufficiently advised, the Commission finds that Case No. 2015-00267 is closed. The Commission accordingly will open this new docket to address EKPC's motion. We further find that EKPC has established good cause to permit a brief extension of time in which to file the journal entries as required pursuant to ordering paragraph 5 of the December 1, 2015 Order.

IT IS THEREFORE ORDERED that:

1. EKPC's motion for a 15-day extension of time is granted.
2. EKPC shall file the journal entries reflecting how the Bluegrass Station transaction was recorded no later than February 12, 2016.
3. This matter is closed and removed from the Commission's docket.
