ORDER

By Order issued August 17, 2015, the Commission adopted and approved a Stipulation and Settlement Agreement (“Stipulation”) entered into between Commission Staff and U.S. 60 Water District (“U.S. 60”) in complete resolution of Case No. 2015-00037.¹

Stipulation, numbered paragraph 2, requires U.S. 60 to:

[!]Internally inspect each of its then-existing water storage tanks no later than six months after the Commission’s acceptance of this Stipulation. U.S. 60 further agrees to submit the inspection reports for each water storage tank to the Commission within thirty days of each report’s completion.²

On February 17, 2016, U.S. 60 tendered a motion for a 45-day extension of the inspection requirement. In support, U.S. 60 states that it has retained Wet or Dry Tank

Inspection to perform the inspection of the two tanks³ subject to the inspection requirement. However, it asserts that due to the inclement weather, the tanks will not be able to be inspected for approximately two weeks beyond the six month time requirement. Therefore, out of an abundance of caution, U.S. 60 requests a 45-day extension.

The Commission, having considered U.S. 60's motion and being otherwise being sufficiently advised, finds that Case No. 2015-00037 is closed and that this case should be opened to consider the merits of U.S. 60's motion. The Commission further finds that U.S. 60 has demonstrated good cause for a 45-day extension of time within which to fulfil the requirements set forth in numbered paragraph 2 to the Stipulation in Case No. 2015-00037.

IT IS THEREFORE ORDERED that:

1. This case is opened for the purpose of considering U.S. 60's motion for an extension of time.
2. U.S. 60's motion for a 45-day extension of time within which to fulfil the requirements set forth in numbered paragraph 2 to the Stipulation in Case No. 2015-00037 is granted.
3. All other terms of the Commission's August 17, 2015 Order and the Stipulation in Case No. 2015-00037 not in conflict with this Order shall remain in full force and effect.
4. This case is closed and removed from the Commission's docket.

³ The tanks to be inspected are the Clay Village standpipe and Driscoll elevated storage tank. U.S. 60's remaining two tanks are not subject to the inspection requirement as the Peytona elevated storage tank is newly constructed, and the Peytona standpipe has been removed from service and is awaiting demolition.
