ORDER

On September 30, 1991, in Case No. 1990-00402, the Commission approved certain adjusted rates for Martin Gas, Inc. ("Martin").¹ In November 2004, Martin proposed and the Commission approved changes to its tariff that included, among other items, changes to its Gas Cost Adjustment clause. Those changes updated the methodology of calculating the components of the Gas Cost Recovery ("GCR") rate.

On February 24, 2016, Martin filed its GCR rate application with rates to be effective April 1, 2016.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Martin's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Martin's notice sets out an Expected Gas Cost ("EGC") of \$5.2207 per Mcf, which is a decrease of \$.0804 per Mcf from its prior EGC of \$5.3011 per Mcf.
- 3. Martin's notice sets out no Refund Adjustment ("RA") for the current quarter and no total RA, which is no change from the prior total RA.

- 4. Martin's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0506) per Mcf. Martin's total AA is (\$.2474) per Mcf, which is an increase of \$.0023 per Mcf from its previous total AA of (\$.2497) per Mcf.
 - 5. Martin's notice sets out no Balance Adjustment.
- Martin's GCR rate is \$4.9733 per Mcf, which is a decrease of \$.0781 per
 Mcf from its previous GCR rate of \$5.0514 per Mcf.
- 7. The rates as proposed by Martin and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Martin on and after April 1, 2016.

IT IS THEREFORE ORDERED that:

- 1. The rates proposed by Martin and set forth in the Appendix to this Order are approved for service rendered on and after April 1, 2016.
- 2. Within 20 days of the date of this Order, Martin shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
