ORDER

On March 14, 2016, Sharpsburg Water District ("Sharpsburg District") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure¹ and the application was accepted for filing as of that date. The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Sharpsburg District purchases water from the Bath County Water District ("Bath District") and city of Carlisle ("Carlisle").
- 2. On February 23, 2016, Bath District notified Sharpsburg District that it would increase its wholesale rate to Sharpsburg District from \$3.31 per 1,000 gallons to \$3.38 per 1,000 gallons effective February 15, 2016.² Sharpsburg District proposed to increase the water rates to its customers effective February 15, 2016, to reflect the increased cost of purchased water.
- 3. Sharpsburg District proposed a purchased water adjustment factor of \$0.07 per 1,000 gallons.

- 4. During the 12 months ended January 31, 2016, Sharpsburg District purchased 69,142,500 gallons of water from Bath District and 35,691,800 from Carlisle and sold 77,912,900 gallons. The increase in the cost of purchased water is \$4,839.97, resulting in a purchased water adjustment factor of \$0.07 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.07 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
 - 6. Sharpsburg District's proposed rates should be approved.
- 7. The rates as set forth in Appendix B to this Order are fair, just and reasonable and should be approved for water service rendered by Sharpsburg District on and after February 15, 2016.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.07 per 1,000 gallons is approved.
- 2. Sharpsburg District's proposed rates, as set forth in Appendix B to this Order, are approved for water service rendered on and after February 15, 2016.
- 3. Within 20 days of the date of this Order, Sharpsburg District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
