COMMISSION STAFF'S SUPPLEMENTAL REQUEST FOR INFORMATION TO
WILLIAM WEINBERG, LOIS WEINBERG, JED WEINBERG, AND ZACHERY
WEINBERG

William Weinberg, Lois Weinberg, Jed Weinberg, and Zachery Weinberg (collectively "Weinbergs"), pursuant to 807 KAR 5:001, are to file with the Commission the original in paper medium and ten copies of the following information. The information requested herein is due within 14 days of the date of this request. Responses to requests for information in paper medium shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

The Weinbergs shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though

correct when made, is now incorrect in any material respect. For any request to which the Weinbergs fail or refuse to furnish all or part of the requested information, they shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, the Weinbergs shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide a corrected transfer of capital stock of Martin Gas and a purchase/sale agreement signed by the parties, as referenced in the response to Item 2 of Commission Staff's Initial Request for Information ("Staff's First Request").

2. Refer to the response to Staff's First Request, Item 7. Explain whether the proposed majority shareholders, Jed Weinberg and Zachary Weinberg, individually have the financial resources needed to be the main lender in the future on shareholder loans comparable to the loan described in the response.
