ORDER

On April 7, 2016, Beech Grove Water System, Inc., ("Beech Grove") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Beech Grove purchases water from the Henderson Water Utility ("Henderson") and from West Daviess County Water District ("West Daviess").
- 2. Henderson notified Beech Grove on January 4, 2016, that its wholesale rate to Beech Grove would decrease from \$3.1275 per 1,000 gallons to \$2.3816 per 1,000 gallons, effective March 1, 2016.² Beech Grove proposed to decrease the water rates to its customers effective April 15, 2016, to reflect the decreased cost of purchased water. However, because Henderson decreased its rate effective March 1, 2016,³ Beech Grove's requested effective date should be denied pursuant to 807 KAR 5:068(2)(2), and Beech Grove's revised rates should be deemed effective March 1, 2016.

- 3. Beech Grove proposed a purchased water adjustment factor of \$(0.70) per 1,000 gallons; due to a rounding error in Beech Grove's request, the purchase water adjustment factor should be \$(0.79) per 1,000 gallons.
- 4. During the 12 months ended February 29, 2016, Beech Grove purchased 67,630,000 gallons of water from Henderson and 4,159,000 from West Daviess, and sold 63,189,723 gallons of water. The decrease in the cost of purchased water is \$(50,445.22), resulting in a purchased water adjustment factor of \$(0.79) per 1,000 gallons.
- 5. The purchased water adjustment factor of \$(0.79) per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
 - 6. Beech Grove's proposed rates should be denied.
- 7. The rates as set forth in Appendix B to this Order, are fair, just and reasonable and should be approved for water service rendered by Beech Grove on and after March 1, 2016.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$(0.79) per 1,000 gallons is approved.
 - 2. Beech Grove's proposed rates are denied.
- 3. The rates set forth in Appendix B to this Order are approved for water service rendered by Beech Grove on and after March 1, 2016.

4. Within 20 days of the date of this Order, Beech Grove shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
