ORDER

The Commission initiated this case by Order entered April 21, 2016, directing North Mercer Water District ("North Mercer") to either satisfy the matters set forth in the formal complaint by Ronald D. McGinnis ("Complainant") or file a written answer within ten days. On May 31, 2016, North Mercer filed a motion for an extension of time to file an answer ("Motion"). In support of its Motion, North Mercer states it "believed it had sufficiently responded to the Commission's inquiry by its April 8, 2016 Response to the Commission investigator."

Complainant initially presented his allegations against North Mercer to the Commission as an informal complaint. The Commission's Consumer Services Division then contacted North Mercer by telephone on April 8, 2016, in an effort to resolve the informal complaint, and the conversation held at that time is the "Response" North Mercer references in its Motion. In that April 8, 2016 Response, North Mercer stated

that there was a pending civil action against Complainant in the Mercer Circuit Court connected to the issues presented herein.

After Complainant filed his formal complaint, the Commission issued an Order to Satisfy or Answer the Complaint on April 21, 2016, and the same was served electronically that date North Mercer on at the e-mail nmwd@burginwireless.com. No response was received from North Mercer within ten days as required by that Order. Commission Staff ("Staff") subsequently contacted counsel for North Mercer on May 11, 2016, to inquire as to North Mercer's response, and was informed that counsel had no knowledge of North Mercer's receipt of the Order. A copy of the Order was faxed and mailed to counsel for North Mercer on May 12, 2016, with the suggestion that North Mercer file a motion for an extension of time to file an answer.² North Mercer's Motion was ultimately filed on May 31, 2016.

The Commission, having considered the Motion, finds that North Mercer should be granted an extension of time of ten days from the date of this Order to file an answer to the complaint.

IT IS THEREFORE ORDERED that:

- North Mercer's motion for an extension of time is granted.
- North Mercer shall file its Answer to the complaint within ten days of the date of this Order.
