COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION  
TO RONALD D. MCGINNIS

Ronald D. McGinnis ("Mr. McGinnis"), pursuant to 807 KAR 5:001, is to file with the Commission the original and five copies of the following information, with a copy to all parties of record. The information requested herein is due within 20 days from the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Mr. McGinnis shall make timely amendment to any prior response if he obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Mr. McGinnis fails or refuses to furnish all or part of the requested information, Mr. McGinnis shall provide a written explanation of the specific grounds for his failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a document containing personal information, Mr. McGinnis shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the document so that personal information cannot be read.

1. State whether you contacted North Mercer Water District (North Mercer) between January 1, 2014, and the current date to request service for any tenants residing at 244 Cap Bottom Lane, Harrodsburg, Kentucky.

a. Confirm whether any such requests were made for service in your name, or in the name of the tenant(s).

b. If such requests were made, provide the following:

(1) Copies of all records documenting the request;

(2) The name of the person(s) for which service was requested;

and

(3) Dates for all starts and/or terminations of service from January 1, 2014, to the current date.

2. Provide copies of all billing and payment records in your possession pertaining to water service provided by North Mercer at 244 Cap Bottom Lane, Harrodsburg, Kentucky, from January 1, 2014, until the current date.
