#### ORDER

On June 6, 2016, North Nelson Water District, ("North Nelson") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. North Nelson purchases water from the Louisville Water Company ("Louisville") and from the city of Bardstown ("Bardstown").
- 2. Louisville notified North Nelson on March 18, 2016, that its wholesale rate to North Nelson would increase from \$2.15 per 1,000 gallons to \$2.20 per 1,000 gallons, and the monthly service charge would increase from \$1,002.00 per month to \$1,050.00 per month, effective July 1, 2016.<sup>2</sup> North Nelson proposed to increase the water rates to its customers effective July 1, 2016, to reflect the increased cost of purchased water.
- 3. North Nelson proposed a purchased water adjustment factor of \$0.05 per 1,000 gallons.

- 4. During the 12 months ended April 30, 2016, North Nelson purchased 202,912,000 gallons of water from Louisville and 91,416,000 from Bardstown, and sold 259,266,400 gallons of water. The increase in the cost of purchased water is \$10,721.60, resulting in a purchased water adjustment factor of \$0.05 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.05 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. The rates as set forth in Appendix B to this Order are fair, just and reasonable and should be approved for water service rendered by North Nelson on and after July 1, 2016.

## IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.05 per 1,000 gallons is approved.
- 2. North Nelson's proposed rates, as set forth in Appendix B to this Order, are approved for water service rendered by North Nelson on and after July 1, 2016.
- 3. Within 20 days of the date of this Order, North Nelson shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
