Airview Utilities, LLC ("Airview"), pursuant to 807 KAR 5:001, is to file with the Commission the original and eight copies of the following information. Pursuant to the Commission's September 6, 2016 Order, the information requested herein is due on or before October 6, 2016. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Airview shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Airview fails or refuses to furnish all or part of the requested information, Airview shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filling a paper containing personal information, Airview shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. State the name and title of each witness that Airview intends to call at the October 12, 2016 hearing. If Airview does not intend to call the individual(s) who prepared or supervised the preparation of Airview's responses to requests for information, then state why the individual(s) will not be called as a witness.

2. Refer to Airview's response to Item 14 of the request for information contained in the Appendix to the Commission's July 29, 2016 Order. Provide a schedule containing a list of Airview's creditors and the corresponding amount owed to each creditor.

3. Refer to Airview's response to Item 17 of the request for information contained in the Appendix to the Commission's July 29, 2016 Order. The request requires Airview to provide, among other things, all related business records that document the process through which the members of Airview authorized the filing of the abandonment. Supply the documents requested by Item 17.

4. Refer to Airview's response to Item 18 of the request for information contained in the Appendix to the Commission's July 29, 2016 Order. The request

requires Airview to provide a copy of each deed, easement, or agreement corresponding to the real property utilized by Airview in providing utility service. Supply the documents requested by Item 18.

5. Airview's responses to the requests contained in the Appendix to the Commission's July 29, 2016 Order were not accompanied by a signed certification of the preparer or the person supervising the preparation of the responses on behalf of Airview that the responses are true and accurate to the best of that person's knowledge, information and belief formed after a reasonable inquiry. Identify the preparer or person supervising the preparation of each response in that filing and provide the required certifications.

6. If the Commission grants the abandonment sought by Airview, provide the journal entries that Airview will record to reflect the abandonment.
