ORDER

On July 13, 2016, Estill County Water District No. 1 ("Estill County") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Estill County purchases water from the city of Irvine Municipal Utilities ("Irvine") and from the Jackson County Water Association ("Jackson County").

2. Irvine notified Estill County on March 22, 2016, that its wholesale rate to Estill County would increase from \$2.571 per 1,000 gallons to \$2.587 per 1,000 gallons effective July 19, 2016.² Estill County proposes to increase the water rates to its customers effective July 19, 2016, to reflect the increased cost of purchased water.

Estill County proposes a purchased water adjustment factor of \$0.03 per
 1,000 gallons.

4. During the 12 months ended May 31, 2016, Estill County purchased 254,522,000 gallons of water from Irvine and 375,299 gallons of water from Jackson

County. During the same period, Estill County sold 166,531,311 gallons of water. The increase in the cost of purchased water is \$4,072.35, resulting in a purchased water adjustment factor of \$0.03 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.03 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Estill County's proposed rates, as set forth in Appendix B to this Order, are fair, just and reasonable and should be approved for water service rendered by Estill County on and after July 19, 2016.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.03 per 1,000 gallons is approved.

2. Estill County's proposed rates, as set forth in Appendix B to this Order, are approved for water service rendered by Estill County on and after July 19, 2016.

3. Within 20 days of the date of this Order, Estill County shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
