ORDER

On August 23, 2016, East Laurel Water District ("East Laurel") submitted an application for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

- East Laurel purchases water from Wood Creek Water District ("Wood Creek").
- 2. Wood Creek notified East Laurel on May 20, 2016 that its wholesale rate to East Laurel would increase from \$2.92 per 1,000 gallons to \$3.42 per 1,000 gallons, effective July 14, 2016.² East Laurel proposed to increase the water rates to its customers effective September 22, 2016, to reflect the increased cost of purchased water.
- East Laurel proposed a purchased water adjustment factor of \$0.73 per
 1,000 gallons.

4. During the 12 months ended July 31, 2016, East Laurel purchased 445,257,690 gallons of water from Wood Creek and sold 304,158,694 gallons of water. The increase in the cost of purchased water is \$222,628.85, resulting in a purchased water adjustment factor of \$0.73 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.73 per 1,000 gallons, as requested by East Laurel and calculated in Appendix A to this Order, is fair, just and reasonable and should be approved.

6. The rates as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service rendered by East Laurel on and after September 22, 2016.

IT IS THEREFORE ORDERED that:

 The purchased water adjustment factor of \$0.73 per 1,000 gallons, as requested by East Laurel, is approved.

 East Laurel's proposed rates as set forth in Appendix B to this Order are approved for water service rendered by East Laurel on and after September 22, 2016.

3. Within 20 days of the date of this Order, East Laurel shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
