COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION TO KENERGY CORP.

Kenergy Corp. ("Kenergy"), pursuant to 807 KAR 5:001, is to file with the Commission the original and ten copies of the following information, with a copy to all parties of record. The information requested herein is due on or before November 23, 2016. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Kenergy shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Kenergy fails or refuses to furnish all or part of the requested information, Kenergy shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Kenergy shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide documentation for the job briefing conducted on October 7, 2014, prior to beginning the work assignment of installing new triplex service on an overhead distribution line to supply electric power to a pole at 9674 US 60, Sturgis, Crittenden County, Kentucky.

2. Refer to the Testimony of Kenneth Stock, page 2, lines 28–37, regarding penalty assessment from and payment to OSHA. Provide copies of documents issued by OSHA during its investigation of the incident that is the subject of this matter, including but not limited to the OSHA citation and any settlement agreement between OSHA and Kenergy.
