ORDER

On October 31, 2016, Louisville Gas and Electric Company ("LG&E") filed an application to revise its Gas Line Tracker ("GLT") rates effective for bills rendered on and after January 1, 2017. Having reviewed the proposed tariff, the Commission finds that further proceedings are necessary to determine its reasonableness and that the proposed tariff should be suspended pursuant to KRS 278.190(2).

IT IS THEREFORE ORDERED that:

1. The propose GLT tariff is suspended five months from January 1, 2017, up to and including June 1, 2017.

 The procedural schedule set forth in the Appendix to this Order shall be followed.

3. Any motion to intervene filed after November 30, 2016, shall show a basis for intervention and good cause for being untimely. If the untimely motion is granted, the movant shall accept and abide by the existing procedural schedule.

4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

5. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
