ORDER

On July 17, 2012, in Case No. 2011-00364,¹ the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's purchased gas cost adjustment clause.

On November 16, 2016, Bluegrass filed its proposed Gas Cost Recovery ("GCR") rate application to be effective January 1, 2017.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- Bluegrass's notice sets out an Expected Gas Cost ("EGC") of \$4.6330 per
 Mcf, which is a decrease of \$.0393 per Mcf from its previous EGC of \$4.6723 per Mcf.
 - 3. Bluegrass's notice sets out no current quarter Refund Adjustment.
- 4. Bluegrass's notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.0119 per Mcf. Bluegrass's total ACA is (\$.5703) per Mcf, which is an increase of \$.0267 per Mcf from its previous total ACA of (\$.5970) per Mcf.

- 5. Bluegrass's notice sets out a current quarter Balance Adjustment ("BA") of \$.0008 per Mcf. Bluegrass's total BA is (\$.0991) per Mcf, which is an increase of \$.0055 per Mcf from its previous total BA of (\$.1046) per Mcf.
- Bluegrass's GCR rate is \$3.9636 per Mcf, which is a decrease of \$.0071
 per Mcf from its previous GCR rate of \$3.9707 per Mcf.
- 7. The rate as proposed by Bluegrass and set forth in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Bluegrass on and after January 1, 2017.

IT IS THEREFORE ORDERED that:

- The rate as proposed by Bluegrass and set forth in the Appendix to this
 Order is approved for service rendered on and after January 1, 2017.
- Within 20 days of the date of this Order, Bluegrass shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.
