**PETITION FOR CONFIDENTIALITY**

Atmos Energy Corporation ("Atmos Energy" or "Company"), by counsel, pursuant to KRS 278.160(3) and 807 KAR 5:001(13) petitions the Commission for confidential protection of the attached special contract, previously designated as the Customer H special contract. One non-redacted and one redacted copy of the special contract are attached.

Atmos Energy previously submitted in this proceeding a special contract with Customer H for approval, along with supporting cost analysis. The special contract and costs analysis was filed under a Petition For Confidentiality. However, Atmos Energy recently discovered that the copy of the special contract that was filed was not a copy of the fully executed contract. The filed copy was executed by Customer H only. The attached copy contains the signatures of both Atmos Energy and Customer H. The only difference between the previously filed contract and the attached is that the attached also bears the signature of Atmos Energy.

For the same reasons set forth in the Petition For Confidentiality for the contract with Customer H previously filed, Atmos Energy requests that the attached non-redacted special contract be granted confidential protection indefinitely.

For those reasons, Atmos Energy requests that the attached non-redacted copy of the special contract and cost analysis be treated as confidential.
