Refer to Columbia's Accelerated Main Replacement Program ("AMRP") 1. Form 1.1 filed in Case No. 2014-00366.1 This page shows that Net AMRP Investment-Property, Plant and Equipment forecast for 2015 was \$16,162,372. AMRP Form 1.1 filed in the instant case lists actual Net AMRP Investment-Property Plant and Equipment for 2015 of \$21,458,014. Identify and describe the factors that contributed to the increased amount of investment.

Response:

Due to forecasted annual budget underruns identified earlier in the year related to the growth and public improvement capital budget classes, Columbia shifted capital over to the AMRP program to meet its commitment to effectively execute on the overall capital program. Columbia also completed several public improvement and compliance/capacity related betterment projects that included the retirement of priority pipe and as a result was included in this increased investment amount. Overall, the projected retirements were somewhat lower

than projected which also contributed to a higher net investment amount than originally projected.
