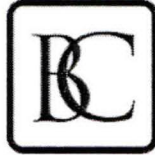

That the District's consultant, Greg Heitzman, will be unavailable the first two weeks of September, including the 13th, due to traveling.


That the Chairman of the Board, Bill Harvey, is likewise unavailable on September 13, 2017.

Wherefore, counsel requests appropriate Orders of the Public Service Commission consistent with this Motion.






